In order to remain competitive and to follow the fluctuation of the Canadian dollar, your confidential Canadian price lists are only available on our website under "Dealer Login". A suggested retail price list is also established, which we hope will maximize your profits while keeping you competitive, but you may sell at any price you choose. Upon approval of your account, UTV Canada will assign your company a login.

### **ORDERING:**

Your order may be placed by telephone at 1-780-979-0620, or by fax at 1-780-979-0363 or online at [www.utvcanada.com](http://www.utvcanada.com). To place your order, you must supply us with part number, quantity, shipping information and method of payment.

### **PAYMENT:**

This document is not a credit application. All accounts will be credit card, bank transfer or C.O.D. only.

### **RETURNS:**

- No returns accepted without an authorization number after 30 days.
- Mark authorization numbers prominently and clearly on the outside of the shipping box.
- Return authorization numbers are valid for a period of 30 days from date of issue.
- It is the responsibility of the Dealer to insure that returns are properly packaged against shipping damage.
- **Returns sent collect, will not be accepted under any circumstances.**
- A copy of the original invoice must be included with every item returned.
- Parts must be in the original package and condition unless defective.
- Minimum 20% re-stocking fee will be charged on returned merchandise, unless defective.
- A price increase is not a valid reason for a product return.
- If you are on Visa or MasterCard, credits will be applied to your card. If you are on bank transfer or C.O.D., a cheque will be issued to you.

### **CLAIMS:**

- We will take no responsibility for any carrier damaged merchandise. Any claim for damage or loss must be addressed directly to the carrier.
- We will not be liable for paint or labor claims of any kind.
- Wrong parts received or shortages must be reported within 2 business days of receipt of order.
